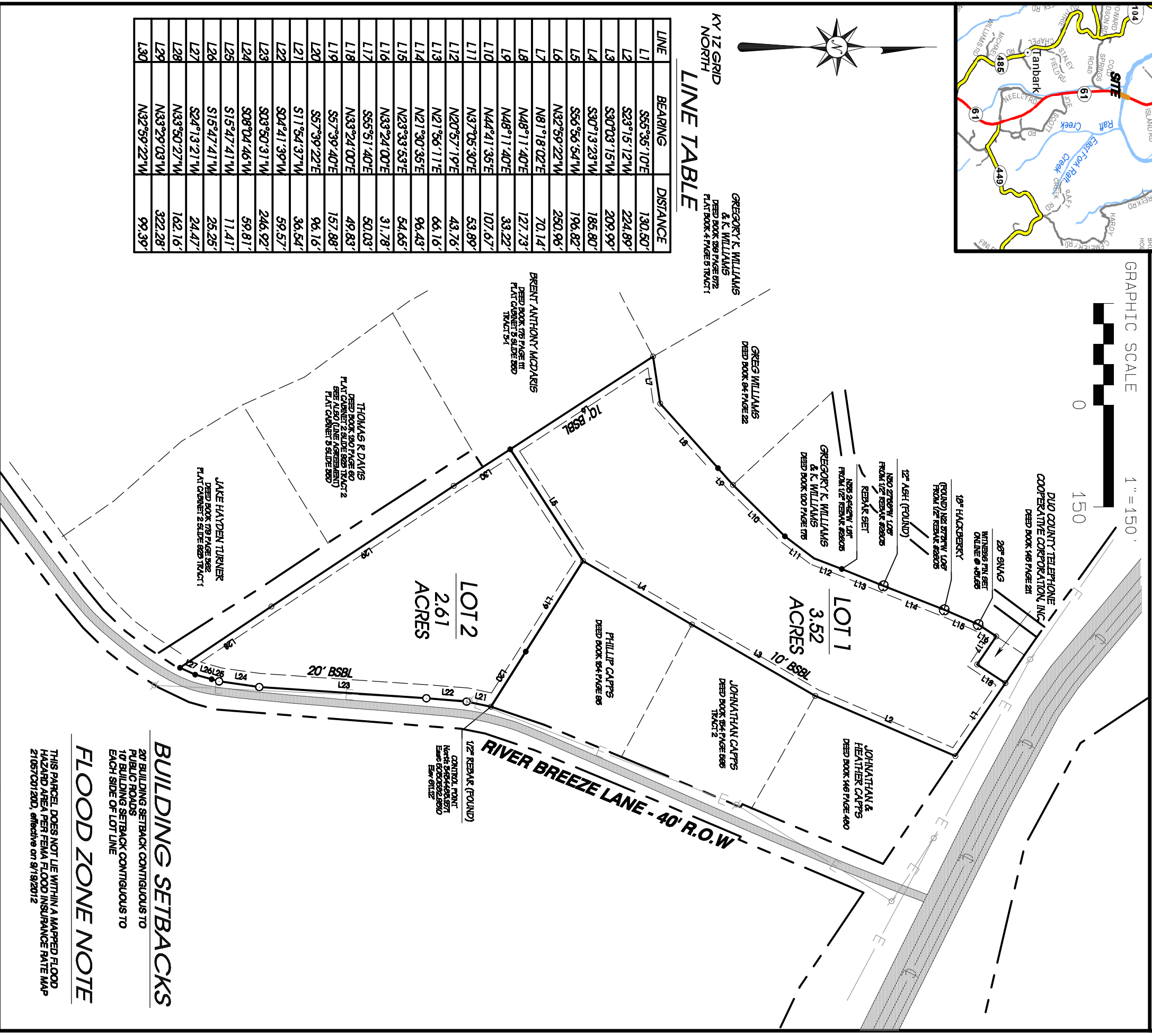
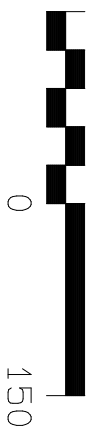


RIVER BREEZE ESTATES - RESUBDIVISION
