GLEE HAYES

This deed of conveyance made and entered into this the 12th day of July 1948, by and between T. C. Koger, Jr. a single person, and James A. Hicks, and wife, Lucille, Hicks, parties of the first part and Glee Hayes, party of the second part; Witnesseth; That for and in consideration of the sum of \$1.00 and other good and valuable consideration, the receipt all of which is hereby fully acknowledged, the parties of the first part do hereby bargain, sell, transfer and convey unto the party of the second part, her heirs and assigns, a certain tract or parcel of real estate, lying and being in Wayne and Clinton Counties, Kentucky, and bounded and described as follows, to-wit;

BEGINNING on a water oak and hickory, thence running S. 4 W. 8 poles to a rock; thence S. 8 E. 36 poles to a rock; thence S. 26 W. 8 poles; thence S. 9 W. 8 poles; thence S. 5 E. 4 poles; thence S. 5 W. 8 poles; thence S. 13 W. 6 poles; thence S. 45 West 16 poles; thence N. 63 W. 18 poles to a stooping black oak; thence N. 55 W. 14 poles to Ahile Bertram's line; thence with his line to a double chesnut corner; and with the same to the top of the mountain; thence with the County line to two gums called for in Spraim Bertram patent; thence with the Bertram patent N. 30 E. 63 poles to a chesnut oak and dogwood; thence N. 1 W. 60 poles to a rock where two hickories are called for; thence N. 51 W. 115 poles to the beginning, Containing One Hundred Acres, more or less.
